PHA Activity Report January - June, 2025:

- 1. January 4-5, 2025: PTDC invited for National Tourism, Investment & Cultural Expo 2025 and the NTP Excellence Awards 2024 held at Pak-China Friendship Center, Islamabad. PHA nominated its Senior Vice Chairman, Barrister Mansoor Ali Shah to attend the event.
- 2. January 05, 2025: On receipt of Invitation as Guest of Honor from COTHM for its 9th Convocation COTHM Karachi held at Pearl-Continental Hotel Karachi, Mr. Khurram Awan, General Manager, Movenpick Hotel Karachi and Executive Committee Member PHA attended the ceremony on behalf of Association.
- 3. January 07, 2025: The 4th Meeting of FPCCI Central Standing Committee on *Tourism Economy* was held on 7th January 2025 at FPCCI Head Office Karachi, convened by *Mr. Salman Javed* Convener of the Committee. The Convener and the Members of the Committee discussed *Pakistan Tourism Forum and the matters related with Tourism Economy*. Members of the Committee including Secretary General PHA attended the meeting.
- 4. **January 08**, **2025**: STDC invited all industry members and stakeholders with updated final draft for a roundtable Meeting at Avari Towers Karachi to gather insights, discuss the potential impact of the policy and assess its effect on the development and growth of Tourism, Hospitality and related services sectors in Sindh.

The key roundtable meeting was convened by Syed Feyaz Ali Shah, Managing Director, Sindh tourism Development Corporation (STDC) and chaired by Mr. Khair Muhammad Kalwar, Secretary Culture and Tourism Government of Sindh. The Meeting focused on discussing the draft of the Sindh Tourism Policy, which has been developed in consultation with stakeholders from the travel, trade and hospitality industry.

Meeting was attended by various eminent figures of these sectors including Mr. Ather Bhutto and Ms. Fouzia Azhar from Pakistan Hotels Association (PHA) and other key stakeholders, experts and industry leaders.

- 5. **January 17, 2025:** On request of Association Member Hotels for intervention against SNGCL's Tariff Change for Hotel Industry, who are sending notices to hotels to regularize their existing General Industry Gas connection in to commercial category. PHA Senior Vice Chairman, Barrister Mansoor Ali Shah met Chairman OGRA on this issue and presented the concerns of the hotel industry. Minutes were shared with members and next step is to meet Additional Secretary Mr. Hassan Mehmood Yousufzai in last week of January, 2025.
- 6. January 22, 2025: A general meeting of hoteliers from Karachi Saddar zone was arranged by Mr. Sabilur Rehman, General Manager, Gulf Hotel, Saddar Karachi inviting Chairman, and Secretary General, Pakistan Hotels Association. Purpose of the meeting was to present issues being faced by the hotels in the vicinity from Food Authorities and police harassment etc. encourage these hotels to become member of Association. Around 15-20 hotel representatives were present and later on, more hoteliers came after the meeting. Mr. Shakir Bhura addressed the audience to redress their issues from PHA forum once, they become member of Association.
