### Procedure of Election

1. A member, who has not paid Association dues before the election takes place, shall not be eligible to stand for election, and cannot exercise the right of vote.
2. Members are required to submit Nomination Forms for the proposed election so as to reach the Registered Office of Pakistan Hotels Association latest by 5.00 P.M. on Wednesday, August 10, 2022.
3. Candidates are to be proposed by one member and seconded by another member as per attached proforma and both the proposer and the seconder, shall be such members as are eligible to vote and not having any dues outstanding to PHA.
4. Members must ensure that their Nomination Form in a sealed envelope marked " Nomination Form " reaches the Registered Office of the Association latest by 5.00 P.M. on Wednesday, the 10th August, 2022. The responsibility of the Nomination Form reaching the Association's office is that of members.
5. Based on nominations received, final list of candidates would be displayed at registered office of the Association and on its website.
6. Polling for Members of the Executive Committee would be held simultaneously at Southern and Northern Zone of the Association in first week of September, 2022, if required.
7. The results of the election will be announced at the Annual General Meeting, notice of which would be mailed separately.
