MINUTES OF ANNUAL GENERAL MEETING

The 57th Annual General Meeting of Pakistan Hotels Association was held at 4.00 P.M. on Wednesday, the 22nd September, 2021 at Pearl-Continental Hotel, Club Road, Karachi. Notice of the meeting along with Agenda was duly circulated before the meeting as per procedure.
